 - a. Consultation with legal counsel regarding legal issues regarding procurement, contracting, and other legal matters relating to construction and expansion of campus.
 - b. Consultation with legal counsel concerning matters on which the attorney's duty to Aristoi Classical Academy under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meeting Laws.

- 6. Hear and discuss update from Masterson Advisors regarding funding options for expansion project at Katy campus. LB

- 8. Discuss, consider, and approve the method of construction for expansion project at Katy campus and authorize administration to prepare solicitation and publish notice for construction project. LB
- 9. Discuss, consider, and approve the contract with Balfour for the 2022-2023 yearbook. MW

Should any final action, final decision, or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive session, then such final action, final decision, or final vote shall be at either:

- (a) The open meeting covered by this Notice upon the reconvening of this public meeting, or
- (b) A subsequent public meeting of the Board upon Notice thereof, as the Board shall determine.

The items listed in this notice may be considered in any order at the discretion of the Board of Directors or the Board President, items listed for closed session discussion may be discussed in open session, and items listed in this notice may be tabled and considered at a subsequent public meeting of the Board of Directors upon proper notice.
